
Step 1: Enter your username and password. Tap **Sign in**.



Step 2: Confirm which device you would like to use for 2SV. Tap **Activate 2SV**.




Step 3: A pop-up will appear confirming you are about to activate 2SV on this device. Tap **Activate 2SV**.




Step 4: A pop-up will appear prompting you to confirm you want to remember your username or card number on this device.

Step 6: Tap 2-step verification settings.




Step 7: If you would like to deactivate 2SV tap **Deactivate** 2SV.
