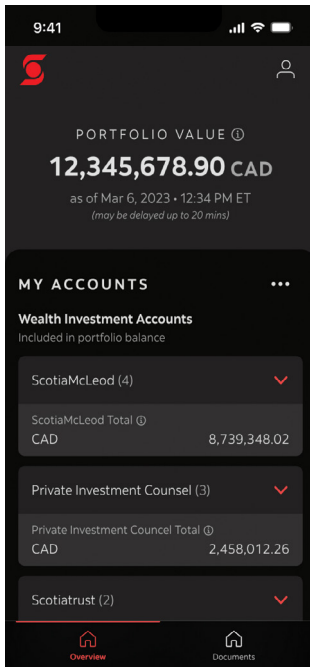


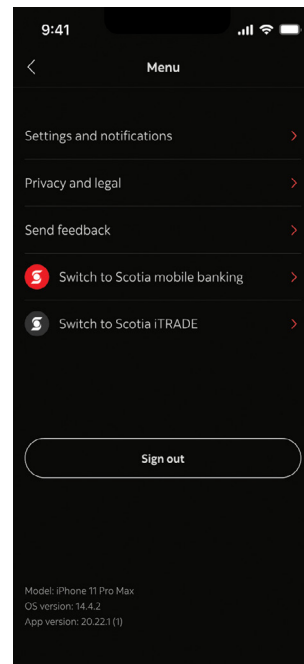

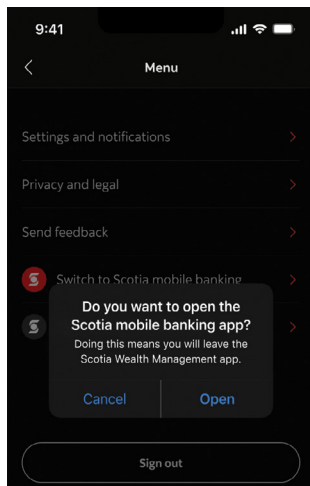
With SSO you can sign in once and access your Scotia Wealth Management accounts, your Scotiabank® banking accounts or your Scotia iTRADE® accounts.



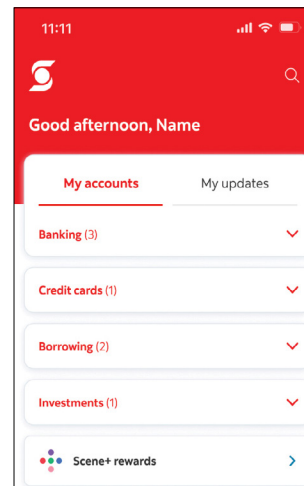
Step 1: Tap the icon on the top right of the Overview page to open the **Menu**.



Step 2: Tap **Switch to Scotiabank** mobile banking to open the mobile banking app. Tap **Switch to Scotia iTRADE** to open the Scotia iTRADE app.



Step 3: A pop-up will appear confirming you want to open either the mobile banking or the Scotia iTRADE app. Tap **Open**.



Step 4: If you selected the Scotiabank mobile banking app the mobile banking app will open. If you selected the Scotia iTRADE app the Scotia iTRADE app will open.
